Contracts will no longer be accepted after July 30.

Your space assignment will be given to you at the time of registration. You may keep your vehicle in your space providing it fits. If your vehicle is oversized and will not fit in your assigned space, you must park your vehicle in the parking lot. Your vehicle must be unloaded and parked into position before 9 A.M. As per the town ordinance, there will be no vehicle movement on the craft field after 9 A.M.

WHAT YOU NEED TO KNOW

DATE: Brielle Day takes place Saturday, September 9, 2023. **This is a one-day-only event - rain or shine - no refunds.**

LOCATION: Brielle Day Craft Fair is located in Brielle Park, 644 Union Lane, Brielle, NJ 08730. You will receive a map with directions the week before Brielle Day.

REGISTRATION: Registration begins 6 A.M. Crafter's registration entrance is located PAST the Brielle Library located on 10 South Street., Brielle, NJ

TIME: The fair opens at 9 A.M. and closes at 4 P.M. Breakdown must start at 4 P.M. All vehicles must be off the field by 5:30 P.M. AS PER TOWN ORDINANCE, no vehicle movement is allowed on the field after 9 A.M. or before 4 P.M.

COMMUNICATIONS

We communicate mostly by EMAIL. It is essential you take the responsibility for receiving and answering these emails. It is your responsibility to add our email address to your contacts, favorites or approved senders list. Be aware we often use Mailchimp to send general announcements and important information to our crafters. We do not have the manpower to follow up with individuals who do not read and respond to our emails. Please do not ignore Mailchimp communications.

GUIDELINES FOR CRAFTERS

TENTS & CANOPIES: All tents, umbrellas, and canopies are required to be secured to the ground with either stakes or weights. **As per our insurance, we will no longer be able to help you set up or tear down.**

ELIGIBILITY: Determination of eligibility is at the discretion of the Brielle Day Craft Fair Committee.

ABOUT YOUR CRAFT:

- 1- The finished product must reflect a high level of skill. ALL ITEMS MUST BE HANDCRAFTED, PAINTED, OR PHOTOGRAPHED BY THE EXHIBITOR OR UNDER THE DIRECT SUPERVISION OF THE EXHIBITOR.
- 2- No part of your craft is allowed to be jobbed out.
- 3- Commercial products are prohibited.
- 4- We try our best to limit the number of crafters in each category.
- 5- Resellers, craft suppliers, and independent representatives of multi-level marketing companies are not eligible.
- 6- We reserve the right to ask you to remove any merchandise we do not consider to be handcrafted.
- 7- Those who have sold items not acceptable and have been asked to refrain from selling those items in the past are prohibited from selling them again.
- 8- We reserve the right to close any exhibit immediately if you have misrepresented your craft on your contract.
- 9- We reserve the right to refuse admittance to future Brielle Day Craft Fairs to anyone who has misrepresented their craft on their contract.
- 10- Please use discretion and keep in mind that this is an event where families will be in attendance.

This is a juried craft fair. However, we have grandfathered some crafters who have been with us faithfully for many years and do not currently meet our criteria.

FOOD VENDORS: all food must be prepackaged beforehand. The exception is the kettle corn vendors. Please bring a copy of your health certificate with you.

LIMITATIONS:

- *No open flames, such as candles allowed.
- *Spaces may not be sublet to any other craft vendor.
- *Spaces may be shared if both crafters have submitted contracts and juried by the Brielle Day Craft Fair Committee.
- *All displays must be kept within your outlined space. At no time may any tables, racks, etc., be moved out into the aisle. This is a requirement for emergency vehicle access.
- *At no time will any games of chance be allowed to be held by any crafter. Doing so is against Municipal law and law enforcement will be called to remove you.
- *If a crafter's proceeds are to go to charity, this must be declared at the time of application.

All responsibility is assumed by the crafter and/or the person who registers. The Borough of Brielle, The Woman's Club of Brielle and volunteers will not be responsible for any damage to or loss of property or work displayed. If I am injured or hurt in any way, I will not make a claim to bring suit against The Borough of Brielle, The Woman's Club of Brielle or volunteers. The Woman's Club of Brielle reserves the right to close any exhibit it deems offensive and/or questionable to the general public. I agree to accept all the terms and conditions contained herein.
